It goes on to highlight how, with a large part of the population living on less than two dollars a day, most African citizens don't appear to be benefiting from the current economic boom.

The Report advocates that by supporting quality education, female entrepreneurship, and the rising middle class, African countries could avoid a future where inequality and poverty persist. This will empower disadvantaged groups who have been left out of the current economic upturn, increasing personal and national wellbeing.

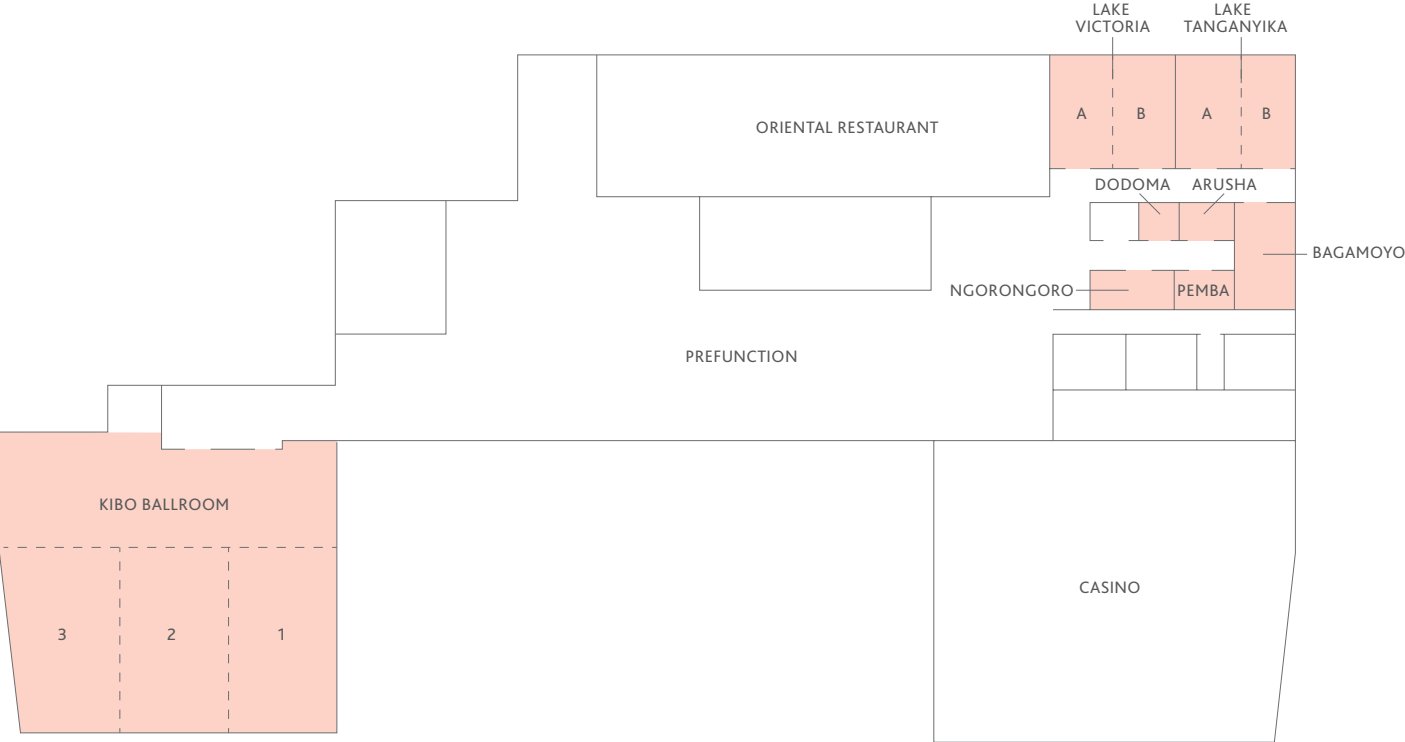

### **Keynote Speech: Unlocking Africa's Potential**

**Day 1, 9.00am**

GDP growth across the continent has fed an "Africa Rising" narrative. However, the situation looks different when viewed in terms of true prosperity. In this keynote speech, Obiageli Ezekwesili will discuss how real development can be achieved through citizens' active participation in economic, political, and social activities.

Ultimately, it is citizens of nations more than any other endowment that can produce prosperity. We know that if citizens are healthy and empowered with the right education—knowledge and skills—they are liberated to become producers of individual and collective prosperity; better than oil, gold, platinum, copper or diamonds.

### **The Africa Prosperity Report Presentation: Analysing African Prosperity**

**Day 1, 10.30am**

National prosperity is about more than just a strong economy. It is also about having the opportunities to succeed in life, to be free from oppression, to access good quality healthcare and education, among other things. In this presentation, Nathan Gamester will present data and analysis from the *Africa Prosperity Report* which provides a comprehensive view of what's happening in Africa beyond traditional economic indicators.

### **Presentation: Lessons From Botswana, An African Success Story**

**Day 1, 10.45am**

Having worked as a diplomat for the Botswana government for many years, Alfred Dube is well-placed to offer insights into how his country has navigated some difficult policy decisions to emerge as one of Africa's success stories. This short speech will draw lessons from Botswana that could provide examples for others to follow.

### **Panel Discussion: Who Are the Drivers of African Prosperity?**

**Day 1, 11.00am**

The 2014 *Africa Prosperity Report* examines in detail three distinct groups of people who are often identified as drivers of African prosperity. They are: the well-educated; female entrepreneurs; and the middle class. This panel discussion will consider each in turn, explaining how these groups could hold the key that could unlock African prosperity.

### A: How Data Can Promote Prosperity

It has been said that if you can't measure it, it doesn't exist. A sustained data revolution is needed to support future prosperity in every African country. The idea that you can't improve what you can't measure is getting more widespread in both the public and private domain. Measurement and accountability are key elements of good policy-making and strategic thinking in both the private and public sphere. This session will emphasise both the need to improve data availability and accuracy and to build a culture of data usage in Africa, which can lead to better decision-making.

### B: Business Values for Prosperity

Successful entrepreneurs often share similar values and principles. In particular our panellists will discuss the importance of trust, vision, leadership and networking in determining the way a business is established and run successfully. The panel will discuss why some firms decide to engage with local communities by offering to apply their business talents and financial resources to address local problems and, in so doing, promote shared prosperity.

Day 1, 3.30pm

### A: Using Indexes to Inform Policy-Making

This special session will examine several indexes that measure progress in Africa. In recent years an increasing number of indexes have been created and, although having the benefit of shedding light on new issues, they may also create confusion in their conflicting rankings. During this session experts from different indexes will discuss the reason behind their index, the impact they have had in the public, private, and third sector, as well as the challenge of summarising complex ideas into a single number and presenting it in an effective way.

### B: Prosperity Pitches—Ethical Business for Prosperity

During this session the attendees will have the opportunity to listen to real experiences from successful African entrepreneurs. Based on their personal experience, our speakers will provide examples of how to start a business in remote areas; transform a social need into a business opportunity; expand a commercial activity (even in business-unfriendly environments); succeed as a female entrepreneur and other business-related challenges.

Day 2, 9.00am

#### **C: Stoking African Innovation: Ways and Means**

Technology and innovation are not only creating new business opportunities, they are revolutionising how people live. The ability to find commercially viable innovations that address problems relevant to Africa is critical in promoting true prosperity. During this session our panellists will focus on a broad spectrum of innovations addressing economic and social needs. These innovations span the oil and gas sector, the agricultural sector, as well as basic services in education, health, water, sanitation, and hygiene among others. The final testimonial to wrap up the session will explain how a simple app can improve family planning in Africa.

#### **D: Urbanisation, Opportunities, and Security Challenges**

Urbanisation is increasing in Africa, linked both to the expansion of existing cities and the emergence of new ones. This poses challenges and opportunities for both the private and the public sector. This session will discuss city expansions—which often translate into the creation of informal settlements and activities—as well as their related impact on personal wellbeing and quality of life. Speakers on this panel represent international organisations as well as local development initiatives.

#### **C: Innovation for Prosperity**

Under the guidance of three experts, delegates attending this session will solve three different case studies related to innovations in soil and water conservation, ways of scaling innovations, and how education can support social innovation.

#### **D: Personal Safety and National Prosperity**

In this special session, experts will discuss regional threats to human security. With several high-profile security challenges in non-conflict environments over recent years—Boko Haram and Garissa attacks for example—as well as past and current conflicts in Africa, safety and security is still a major challenge for many African countries. The effects of these spill over into other countries, both directly in terms of security challenges and indirectly in terms of displaced people seeking a safer environment. The speakers in this session will examine some of these events, discuss how they impact on citizens' personal safety, and explore how they could impact future prosperity. They will also suggest initiatives—both local and global—to help resolve them.

## How Women Can Lead the ICT Revolution

Day 2, 2.00pm

In this special session we will explore how women can succeed in new and innovative sectors that have been traditionally male-dominated such as ICT and aviation. Our speakers will reveal how they succeeded in their careers and what can be done to empower and support more women who are emerging as business leaders. By championing these women, we echo a key message from the 2014 *Africa Prosperity Report*: empowering women entrepreneurs will change Africa for the better and will have a multiplier effect in their communities, fuelling economic growth and social progress.

## Lessons Learned: How to Move Forward

Day 2, 3.30pm

In order to get the most out of the Summit, this session will hear from some of our high-profile speakers and attendees who will each summarise some key messages that have emerged during the two days. We have selected experts with different affiliations and skills in order to offer a multi-disciplinary summary of the main problems, opportunities, and action points that have emerged from the conference.

*Chief Economist, the African Center for Economic Transformation*

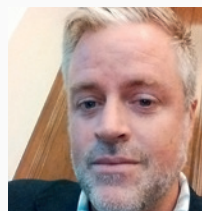

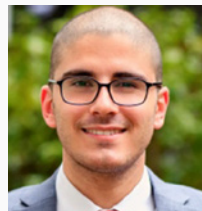
**Celia Waring**

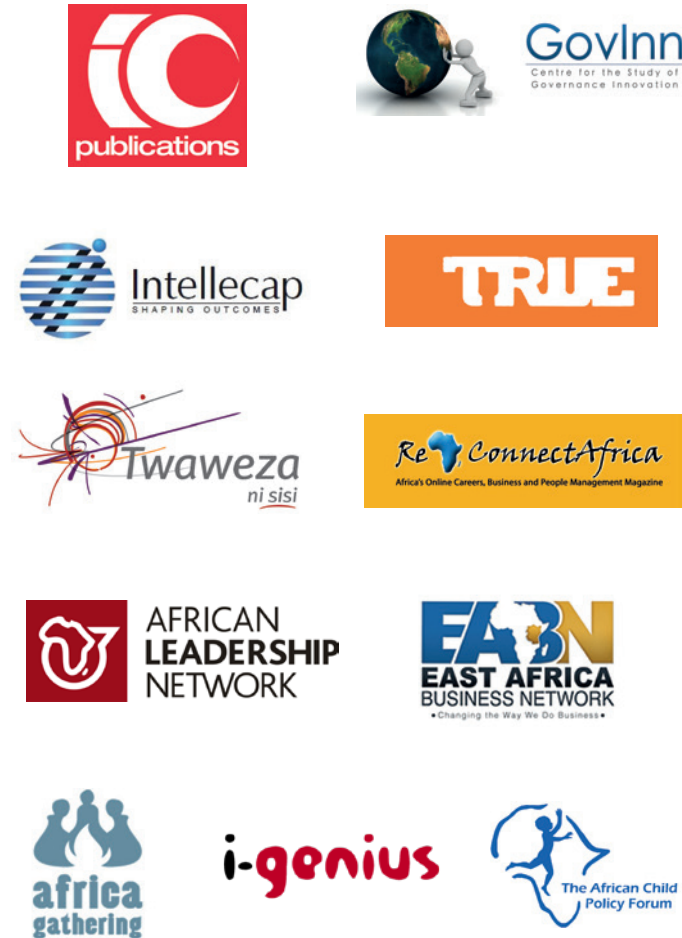

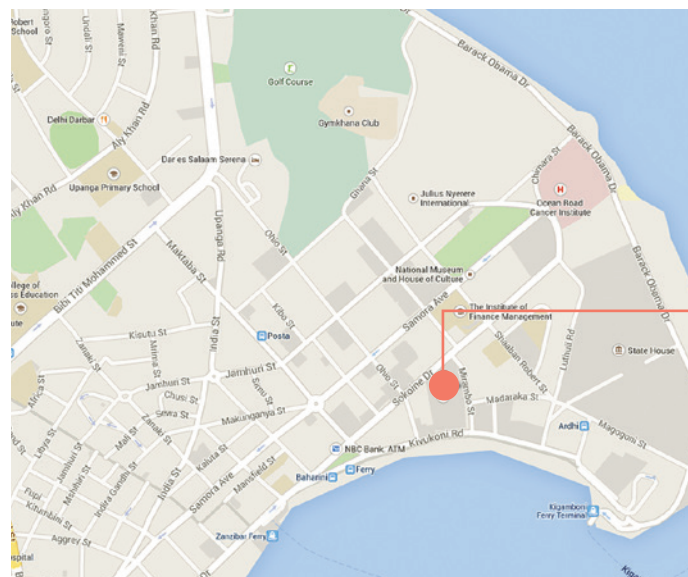
